1) Strategic Partnerships – revision of current partnerships / Z. Novotná See Annex 1

Based on Guidelines on Strategic Partnership (1/2017) as approved in November 2017, Z. Novotná prepared list of current partnerships that could be considered as strategic – both research partnerships and institutional partnerships. The list was prepared based on signed memoranda of understanding (and similar co-operation agreements), however, there could be cases where the cooperation is no longer active (e.g. because research group leader(s) retired or left the institute). Therefore, the list needs to be further reviewed with respect to current joint activities – esp. in case of research partnerships.

Decision(s):

- a) Research strategic partnerships (as proposed by Annex 1) will be reviewed from the perspective of current cooperation (publications, projects) and also amended by guarants (responsible person for) of the particular partnership. Afterwards, the list will be approved by the Deputy Director for Research (in line with Art. 3 Par. 3 of the Guidelines on Strategic Partnership).
- b) List of research strategic partnership will be amended with Europen infrastructures (e.g. EuroBioImaging).
- c) List of planned strategic partnerships will be amended with institutes from Vienna and Olomouc.
- d) Final list of strategic partnerships to be presented to the Director's Board in February/March 2018.

b. Proposal of MU Directive on GDPR / M. Marcolla

M. Marcolla summarized comments prepared by CEITEC MU to the proposal of MU Directive on GDPR. The proposal reflects new rules for GDPR (to be valid from May 2018). Beside the MU Directive, CEITEC MU needs to prepare own measure on GDPR that will reflect specific conditions of the institute. Before the measure will be prepared, we need to assess current situation at CEITEC MU (all workplaces, including research groups and core facilities) and type of personal data we process.

Decision(s):

- a) Analysis of current status regarding GDPR will be presented to the management.
- b) Proposal of Director's Measure on GDPR will be prepared (after poing a) is fulfilled).
- c) Comments on MU Directive (proposal) on GDPR to be sent to the rectorate in given deadline.
