1) EU-life / Z. Novotná

The Community Meeting of EU-life is planned for 22.-23. October 2018 in Barcelona (organizer: CRG). Z. Novotná updated personal changes in the working groups and proposed new members.

a. Emergency announcement / M. Pokorná

Recently, there was an emergency announcement in A35 (code 1000). Despite that all employees are informed on "code 1000" during the training of work safety, the announcement is not well formulated, and employees reported that they did not know how to proceed.

Code 1000 refers to the situation of possible danger that must be confirmed. In case of confirmation, an evacuation is called. In case that the emergency is not confirmed, there is currently no announcement established.

Decision(s):

- a) Campus management (SUKB) will be asked to change the content of the announcement to "There may be a possible emergency. Please wait for further instructions."
- b) Campus management (SUKB) will be asked to add also an announcement that the code 1000 was cancelled (the emergency situation was not confirmed).
