Minutes

1) Space allocation update / M. Marcolla

See Annex 1

M. Marcolla presented an amended version of the space allocation rules that includes a system of positive and negative points that are used for space allocation. There will be a minimum space allocation defined. Thanks to this system, we will be able to identify groups that are candidates for reduction of allocated space and groups that will receive new space. The demand is now high especially for office premises.

Decision(s):

The updated space allocation rules will be consulted with O. Slabý (Chair of the Space Allocation Committee) and with the Director's Board. Afterwards, the implementation will be launched.

2) Information on publication activities (info brochure) / M. Pokorná

Department of Strategy and Science prepared updated information on publication activities. An agreement about joint publications in IS MUNI (locking of publications in IS, the definition of guarantor) was done on meeting with vice-deans of the Faculty of Science and the Faculty of Medicine and with the scientific secretary. The definition of Guarantor of the Result was unified. The document will be distributed to researchers.

3) Bonus system - communication regarding data control / M. Pokorná

N. Kostlánová: Group leaders that were affected by wrong calculation of the bonus system budget allocation are being informed.

Decision(s):

Group leaders will receive their data including used formulas to increase the transparency of the calculation.

The grant proposals should not include specific requirements for space allocation. The general statement that "adequate space in line with the institutional space allocation policy will be allocated" should be used instead of that.
