

Masaryk University Faculty of Law Measure No. 9/2023

On the transfer of doctoral students, whose accreditation expires on 31 December 2024

(as amended with effect from 1 October 2023)

Since the Faculty of Law of Masaryk University (hereinafter referred to as "the Faculty") will cease to be authorised to implement the doctoral study programme "Theoretical Legal Studies" (hereinafter referred to as "the terminating programme") on 31 December 2024 and it is necessary to regulate the transfer of students of the terminating programme to the successor doctoral study programmes in order to enable them to successfully complete their studies, I am issuing the following measure pursuant to Article 5 of Masaryk University Measure No.2/2019:

Article 1

- 1. Students of the terminating programme who submit their dissertation and apply for the dissertation defence by 13 September. 2024 (including application for the state doctoral examination if they have not already passed it), and by this deadline they also fulfil the other study obligations of the terminating programme, will be transferred to the successor doctoral study programme between 16 December 2024 and 31 December 2024, unless their studies end before 16 December 2024.
- 2. Students of the terminating programme who do not fulfil the condition according to the previous paragraph will be transferred to the successor doctoral programme **between** 16 September 2024 and 20 September 2024.
- 3. The successor doctoral study programmes are:
 - a. **International Law Studies** (PrF MS) for the field of *International and European Law* and the field of *Private International Law* of the terminating programme,
 - b. **Private Law and Civil Procedural Law** (PrF SPaCPP) for the fields of *Civil Law, Commercial Law* and *Labour Law* of the terminating programme,
 - c. **Theory and History of Law** (PrF TDP) for the field of *History of Law and Roman Law* and the field of *Theory of Law* of the disappearing programme,
 - d. **Criminal Law** (PrF TRPR_) for the field of *Criminal Law* of the disappearing programme,
 - e. **Constitutional Law and State Studies** (PrF USPS_) for the field of *Constitutional Law and State Studies*,
 - f. **Public Law Studies** (PrF VPS) for the field of *Administrative and Environmental Law* and the field of *Financial Law and Financial Sciences* of the terminating programme

(hereinafter referred to as "successor programmes").

Article 2

1. Students are informed of their transfer to the successor doctoral programmes identified in the previous article by notification.

- 2. The transfer does not affect the calculation of the total study time. For the purposes of determining tuition fees and awarding scholarships, study in the terminating programme is not considered unsuccessful.
- 3. Enrollment in the next semester after the transfer date specified in Article 1 (hereinafter referred to as the "transfer point") shall be made in the successor program. If the student has met the requirements for enrolment in the next semester in the terminating programme and requests enrolment, the student will be enrolled in the successor programme for the next semester with the consent of the instructor.
- 4. Courses for the semester in which the transfer takes place are registered by the student after the time of transfer.
- 5. The transfer also applies to persons whose studies are interrupted in accordance with Section 54 of the Act and Article 13 of the MU Study and Examination Regulations. Pursuant to Article 8 of Masaryk University Measure No. 2/2019, the transfer does not apply to students who are parties to proceedings to terminate their studies; in the event that these proceedings are terminated without the termination of studies, the transfer takes place immediately after the termination of the proceedings.

Article 3

- 1. The research focus of the dissertation, as well as the assigned supervisors or advisors (if any), will not change for students subject to transfer.
- 2. If the transfer requires a change in the student's individual plan of study, the student or advisor shall propose the change by the end of the first semester in which the student is enrolled in the successor program after the transfer. Individual study plans, as well as changes thereto, shall be approved by the departmental board of the successor programme from the time of transfer.
- 3. From the moment of transfer, the transferred student is obliged to fulfil the study obligations in the successor programme.
- 4. The study requirements that have been fulfilled in the terminating programme up to the time of transfer and that are identical in content to the study requirements in the successor programme are deemed to have been fulfilled in the successor programme. This also applies to the obligations to pass the final state examination.
- 5. The obligation to complete **courses of the full-faculty basis** (courses whose code begins with the letters "DS" in the successor programmes) to the extent of at least **12** credits (ECTS) is also considered fulfilled when the corresponding courses of the terminating programme are completed according to Annex 1.
- 6. The obligation to complete courses related to the preparation of the dissertation, professional publications, conference presentations, internationalisation and the development of teaching skills (courses whose code begins with the letters "DI" in the successor programmes), to the extent of at least 180 credits (ECTS), is also deemed to be fulfilled if the corresponding courses of the terminating programme are completed according to Annex 2.
 - Since, according to Article 8(3) of Masaryk University Measure No.2/2019, the faculty is obliged to ensure that the conditions to be fulfilled by the student affected by the transfer are not made more difficult as a result of the transfer to the successor study programme, students subject to the transfer are not obliged to take the course of the successor programme DIINTER Internationalization. They may obtain the corresponding number of 6 credits (ECTS) by completing other courses

- of the successor programme or the terminating programme up to the time of transfer.
- 7. The obligation to complete **professional courses** (courses whose code begins with "**DO**" in the successor programmes) within the scope of **48** credits (ECTS) is also deemed to be fulfilled by completing all compulsory professional courses in the relevant field of study of the terminating programme. In the event that not all the compulsory professional courses in the relevant field of study of the losing programme have been completed, the courses that have been completed shall be counted to the extent of their credit; the student is subsequently required to complete the courses in the successor programme only to the extent necessary to achieve the total of 48 ECTS credits. The compulsory courses in the successor programme shall be considered as compulsory electives for these purposes, unless the board of the successor programme decides otherwise by the time of the transfer.

Article 4

- 1. I am entrusting the implementation of this measure to the Department for Doctoral Studies and Rigorosis Proceedings.
- 2. I hereby delegate the interpretation of the individual provisions of this measure and the control of compliance with this measure to the Vice-Dean for Doctoral Studies and Rigorosum Proceedings.
- 3. This measure shall enter into force on 1 October 2023.
