## Measures of the Faculty of Economics and Administration of MU No. 10/2019

# on submitting a final bachelor's or master's thesis in a language other than the language in which the study programme is accredited

### (in the wording effective since 1 September 2024)

Pursuant to Section 28(1) of Act No. 111/1998 Coll., on Higher Education Institutions and on Amendments and Supplements to Other Acts (the Higher Education Act), as amended (the Higher Education Act), I issue the following Measure:

#### Section 1 Subject

(1) This Measure sets out the conditions for writing bachelor's and master's theses (hereinafter referred to as theses) in a language other than the language in which the study programme is accredited, especially in a foreign language for students enrolled in study programmes in which Czech is the teaching language. The Measure is issued in the context of the provisions of Section 36(6) of the Study and Examination Regulations of Masaryk University.

#### Section 2

### Language of bachelor and master thesis

(1) The student must prepare and submit the thesis in the language of the programme or in the language specified in the programme specification. If not prohibited by the programme specification, it may also be written in English.

# Section 3

# Exceptions for using another language

- (1) Within all programmes accredited at ECON MUNI, in which Czech is the teaching language, theses may also be prepared and submitted in Slovak.
- (2) Students who wish to prepare and submit a thesis in a language other than the language in which the programme of study is accredited and other than that specified in Section 3, paragraph 1, must request the Dean's approval through the faculty's Office for Studies; the request shall be made in the usual manner specified by the Office for Studies.
- (3) The application will be granted if the supervisor of the thesis and the head of the relevant department agree.
- (4) The provisions of this Measure shall also apply mutatis mutandis in the context of pooled studies.

### Section 4

Language of documents related to the bachelor's and master's thesis

- (1) All formal documents related to the preparation of theses, in particular the Thesis Assignment in the IS MU application and in printed form, thesis supervisor and reader's reports, the thesis defence report, etc., are prepared in the language specified as the language of instruction for the study programme.
- (2) English may be used for the supervisor and reader's reports, regardless of the specified language of instruction of the programme, without further administrative measures.

(3) For the supervisor and reader's reports in a programme where Czech is the teaching language, Slovak may be used without further administrative measures.

# Section 5

# **Final provisions**

- (1) This Measure repeals MU Faculty of Economics and Administration Measure No. 10/2019 effective since 9 October 2019.
- (2) I hereby delegate the interpretation of the individual provisions of this Measure to the Vice-Dean for Full-Time Studies.
- (3) Compliance with this Measure is monitored by the heads of the relevant disciplinary departments.
- (4) This Measure belongs to the methodological management area "Study matters and fees related to studies in Bachelor's and Master's degree programmes taught in the Czech language."
- (5) This Measure becomes effective on the date of signature.
- (6) This Measure enters into force on 1 September 2024.
