

Lent money 10000

interest rate

10 % p.a.

Maturity

1 year

How much will be the price after two months?

The offered discount rate is 11 % p. a.

Solution:

$$FV=10000*(1+0.1*1)=11000$$

$$PV(\text{after_2m})=11000*(1-0.11*9/12)=10092.3$$
