<u>IV054 CHAPTER 3:</u> Cyclic and convolution codes

Cyclic codes are of interest and importance because

- They posses a rich algebraic structure that can be utilized in a variety of ways.
- They have extremely concise specifications.
- They can be efficiently implemented using simple <u>shift registers.</u>
- Many practically important codes are cyclic.

Convolution codes allow to encode streams od data (bits).

IMPORTANT NOTE

In order to specify a binary code with 2^k codewords of length n one may need to write down

 2^k

codewords of length n.

In order to specify a linear binary code with 2^{k} codewords of length n it is sufficient to write down

codewords of length n.

In order to specify a binary cyclic code with 2^k codewords of length n it is sufficient to write down

k

codeword of length n.

IV054 BASIC DEFINITION AND EXAMPLES

Definition A code C is cyclic if

(i) C is a linear code;

(ii) any cyclic shift of a codeword is also a codeword, i.e. whenever \boldsymbol{a}_0, \ldots $\boldsymbol{a}_{n-1} \in$ C, then also a then also $\bm{{a}}_{\mathsf{n-1}}$ $\bm{{a}}_{\mathsf{0}}$ … $\bm{{a}}_{\mathsf{n-2}}$ \in $\bm{\mathsf{C}}$.

Example

(i) Code C = {000, 101, 011, 110} is cyclic.

(ii) Hamming code $Ham(3, 2)$: with the generator matrix

is equivalent to a cyclic code.

(iii) The binary linear code {0000, 1001, 0110, 1111} is not a cyclic, but it is equivalent to a cyclic code.

(iv) Is Hamming code $Ham(2, 3)$ with the generator matrix

IV054 FREQUENCY of CYCLIC CODES

Comparing with linear codes, the cyclic codes are quite scarce. For, example there are 11 811 linear (7,3) linear binary codes, but only two of them are cyclic.

Trivial cyclic codes. For any field F and any integer $n \geq 3$ there are always the following cyclic codes of length n over \digamma :

- No-information code code consisting of just one all-zero codeword.
- Repetition code code consisting of codewords $(a, a, ..., a)$ for $a \in F$.
- Single-parity-check code code consisting of all codewords with
" parity 0.
- No-parity code code consisting of all codewords of length *n*

For some cases, for example for $n = 19$ and $F = GF(2)$, the above four trivial cyclic codes are the only cyclic codes.

IV054 POLYNOMIALS over GF(q)

A codeword of a cyclic code is usually denoted

 \bm{a}_0 a $_{1}$ …a $_{$ n -1

and to each such a codeword the polynomial

$$
a_0 + a_1 x + a_2 x^2 + \dots + a_{n-1} x^{n-1}
$$

will be associated.

<u>NOTATION</u>: $F_q[x]$ denotes the set of all polynomials over $GF(q)$.

 $deg (f(x))$ = the largest m such that x^m has a non-zero coefficient in $f(x)$.

<u>Multiplication of polynomials</u> If f(*x*), g (*x*) \in F_q [*x*], then $deg(f(x) g(x)) = deg(f(x)) + deg(g(x)).$

<u>Division of polynomials</u> For every pair of polynomials a(x), b(x) ≠ 0 in F_q[x] there
exists a unique pair of polynomials q(x), r(x) in F_q[x] such that $a(x) = q(x)b(x) + r(x)$, deg $(r(x)) < deg (b(x))$.

Example Divide $x^3 + x + 1$ by $x^2 + x + 1$ in $F_2[x]$.

Definition Let f(*x*) be a fixed polynomial in $F_{\mathrm{q}}[x]$. Two polynomials g(*x*), h(*x*) are said to be congruent modulo f(*x*), notation to be congruent modulo $f(x)$, notation

 $g(x) \equiv h(x) \pmod{f(x)}$

if $g(x)$ - h(x) is divisible by $f(x)$.

IV054 RING of POLYNOMIALS

The set of polynomials in $F_q[x]$ of degree less than deg (f(x)), with addition and prms a **ring denoted** F_q[x]/f(x).

Example Calculate $(x + 1)^2$ in $F_2[x]$ / $(x^2 + x + 1)$. It holds $(x + 1)^2 = x^2 + 2x + 1 \equiv x^2 + 1 \equiv x \pmod{x^2 + x + 1}$.

How many elements has $\mathsf{F}_\mathsf{q}[{\mathsf{x}}]$ / f(x)? Result | $F_q[x] / f(x)$ | = $q^{deg(f(x))}$.

Example Addition and multiplication in $F^2[X]$ / (x² + x + 1)

Definition A polynomial f(*x*) in *F*_q[*x*] is said to be reducible if f(*x*) = a(*x*)b(*x*), where a(*x*), e *F*_q[*x*] and $a(x)$, $b(x) \in F_{q}[x]$ and

 $deg (a(x)) < deg (f(x)),$ $deg (b(x)) < deg (f(x)).$

If f(*x*) is not reducible, it is <mark>irreducible</mark> in $\mathsf{F}_\mathsf{q}[x]$.

Theorem The ring $F_{\mathrm{q}}[x]$ / f(x) is a <u>field</u> if f(x) is irreducible in $F_{\mathrm{q}}[x]$.

Computation modulo $x^\mathsf{n}-\mathsf{1}$

Since $x^n \equiv 1 \pmod{(x^n - 1)}$ we can compute $f(x)$ mod $(x^n - 1)$ as follows: In f(x) replace x^n by 1, x^{n+1} by x, x^{n+2} by x^2 , x^{n+3} by x^3 , ...

Identification of words with polynomials

 $a_0 a_1... a_{n-1} \leftrightarrow a_0 + a_1 x + a_2 x^2 + ... + a_{n-1} x^{n-1}$

Multiplication by x in $R_{\sf n}$ corresponds to a single cyclic shift $x (a_0 + a_1 x + ... a_{n-1} x^{n-1}) = a_{n-1} + a_0 x + a_1 x^2 + ... + a_{n-2} x^{n-1}$

IV054 Algebraic characterization of cyclic codes

Theorem A code C is cyclic if C satisfies two conditions (i) $a(x)$, $b(x) \in C \implies a(x) + b(x) \in C$ (ii) a(x) \in C, r(x) \in R_n \Rightarrow r(x)a(x) \in C

Proof

(1) Let C be a cyclic code. C is linear \Rightarrow (i) holds. (ii) Let $a(x) \in C$, $r(x) = r_0 + r_1x + ... + r_{n-1}x^{n-1}$ $r(x)a(x) = r_0a(x) + r_1xa(x) + ... + r_{n-1}x^{n-1}a(x)$

is in C by (i) because summands are cyclic shifts of $a(x)$.

(2) Let (i) and (ii) hold

- \bullet Taking r(x) to be a scalar the conditions imply linearity of C.
- Taking $r(x) = x$ the conditions imply cyclicity of C.

IV054 CONSTRUCTION of CYCLIC CODES

Notation If f(x) $\in R_{n}$, then

 $\langle f(x) \rangle = \{f(x)f(x) \mid f(x) \in R_n\}$

Theorem For any f(x) $\in R_{\sf n}$, the set $\langle {\sf f}({\sf x})\rangle$ is a cyclic code (generated by f).

Proof We check conditions (i) and (ii) of the previous theorem.

IV054 Characterization theorem for cyclic codes

We show that all cyclic codes C have the form C = $\langle f(x) \rangle$ for some $f(x) \in R_{n}.$

Theorem Let C be a non-zero cyclic code in R_n . Then

- \bullet there exists unique monic polynomial g(x) of the smallest degree such that
- $C = \langle g(x) \rangle$
- $g(x)$ is a factor of x^n -1.

Proof

(i) Suppose $g(x)$ and $h(x)$ are two monic polynomials in C of the smallest degree. Then the polynomial $g(x)$ - h(x) \in C and it has a smaller degree and a multiplication by a scalar makes out of it a monic polynomial. If $g(x) \neq h(x)$ we get a contradiction.

IV054 Characterization theorem for cyclic codes

(iii) Clearly,

and therefore $r(x) = -q(x)g(x)$ (mod $x^n -1$) and $r(x) \in C \Rightarrow r(x) = 0 \Rightarrow g(x)$ is a factor of x^n -1.

GENERATOR POLYNOMIALS

Definition If for a cyclic code C it holds

 $C = \langle g(x) \rangle$,

then g is called the **generator polynomial** for the code *C*.

IV054 HOW TO DESIGN CYCLIC CODES?

The last claim of the previous theorem gives a recipe how to get all cyclic codes of the given length n.

Indeed, all we need to do is to find all factors of

 x^n -1.

Problem: Find all binary cyclic codes of length 3.

IV054 Design of generator matrices for cyclic codes

Theorem Suppose C is a cyclic code of codewords of length n with the generator polynomial

$$
g(x) = g_0 + g_1 x + \dots + g_r x^r.
$$

Proof

(i) All rows of \boldsymbol{G}_1 are linearly independent.

IV054 POLYNOMIAL REPRESENTATION of DUAL CODES

Proof A polynomial $c(x) = c_0 + c_1x + ... + c_{n-1}x^{n-1}$ represents a code from C if $c(x)h(x) = 0$. For $c(x)h(x)$ to be 0 the coefficients at x^k, \ldots, x^{n-1} must be zero, i.e.

Definition If $p(x)$ is an irreducible polynomial of degree r such that x is a primitive element of the field $F[x] / p(x)$, then $p(x)$ is called a primitive polynomial.

Theorem If $p(x)$ is a primitive polynomial over $GF(2)$ of degree r, then the exclusion of $\alpha(x)$ the cyclic code $\langle {\sf p}({\sf x}) \rangle$ is the code Ham (r,2).

IV054 BCH codes and Reed-Solomon codes

To the most important cyclic codes for applications belong BCH codes and Reed-Solomon codes.

Definition A polynomial *p* is said to be <u>*minimal*</u> for a complex number *x* in Z_q if p(*x*) =

If $n = q^m$ - 1 for some m , then the BCH code is called primitive.

Definition A Reed-Solomon code is a primitive BCH code with $n = q$ - 1.

Properties:

• Reed-Solomon codes are self-dual.

1BHC stands for Bose and Ray-Chaudhuri and Hocquenghem who discovered these codes.

IV054 CONVOLUTION CODES

Very often it is important to encode an infinite stream or several streams of data say of bits.

Convolution codes, with simple encoding and decoding, are quite a simple generalization of linear codes and have encodings as cyclic codes.

An (n,k) convolution code (CC) is defined by an $k \times n$ generator matrix, entries of which are polynomials over $\mathsf{F}_\mathsf{2.}$

For example,

 $G_1 = [x^2 + 1, x^2 + x + 1]$

is the generator matrix for a (2,1) convolution code $\mathbf{CC}_{\mathbf{1}}$ and

$$
G_2 = \begin{pmatrix} 1+x & 0 & x+1 \\ 0 & 1 & x \end{pmatrix}
$$

is the generator matrix for a (3,2) convolution code \mathtt{CC}_2

IV054 ENCODING of FINITE POLYNOMIALS

An (n,k) convolution code with a k x n generator matrix G can be used to encode ak-tuple of plain-polynomials (polynomial input information)

 $I=(I_0(x), I_1(x),...,I_{k-1}(x))$

to get an n-tuple of crypto-polynomials

 $C=(C_0(x),\,C_1(x),...,C_{n-1}(x))$

As follows

 $C=1$. G

EXAMPLES

(x3 + x + 1).G1 = (x3 + x + 1). (x2 + 1, x2 + x + 1)= (x5 + x2 + x + 1, x5 + x4 + 1)

EXAMPLE 2

(x2 + x, x3 + 1).G2 = (x2 + x, x3 + 1)\begin{pmatrix} 1 + x0x + 1 \\ 0 & 1 \end{pmatrix}
$$

IV054 ENCODING of INFINITE INPUT STREAMS

The way infinite streams are encoded using convolution codes will beIllustrated on the code CC $_{\rm 1}$.

An input stream I = (I₀, I₁, I₂,…) is mapped into the output stream $C = (C_{00}, C_{10}, C_{01}, C_{11} ...)$ defined by

 $C_0(x) = C_{00} + C_{01}x + ... = (x^2 + 1) I(x)$

and

$$
C_1(x) = C_{10} + C_{11}x + ... = (x^2 + x + 1) I(x).
$$

The first multiplication can be done by the first shift register from the next figure; second multiplication can be performed by the second shift register on the next slide and it holds

$$
C_{0i} = I_i + I_{i+2},
$$
 $C_{1i} = I_i + I_{i-1} + I_{i-2}.$

That is the output streams \boldsymbol{C}_0 and \boldsymbol{C}_1 are obtained by convolving the input stream with polynomials of $\mathbf{G}_{\boldsymbol{\mathit{1}}}$

IV054 ENCODING

The first shift register

will multiply the input stream by x^2+1 and the second shift register

will multiply the input stream by x^2+x+1 .

IV054 ENCODING and DECODING

The following shift-register will therefore be an encoder for the code CC₁

For encoding of the convolution codes so called

Viterbi algorithm

Is used.
