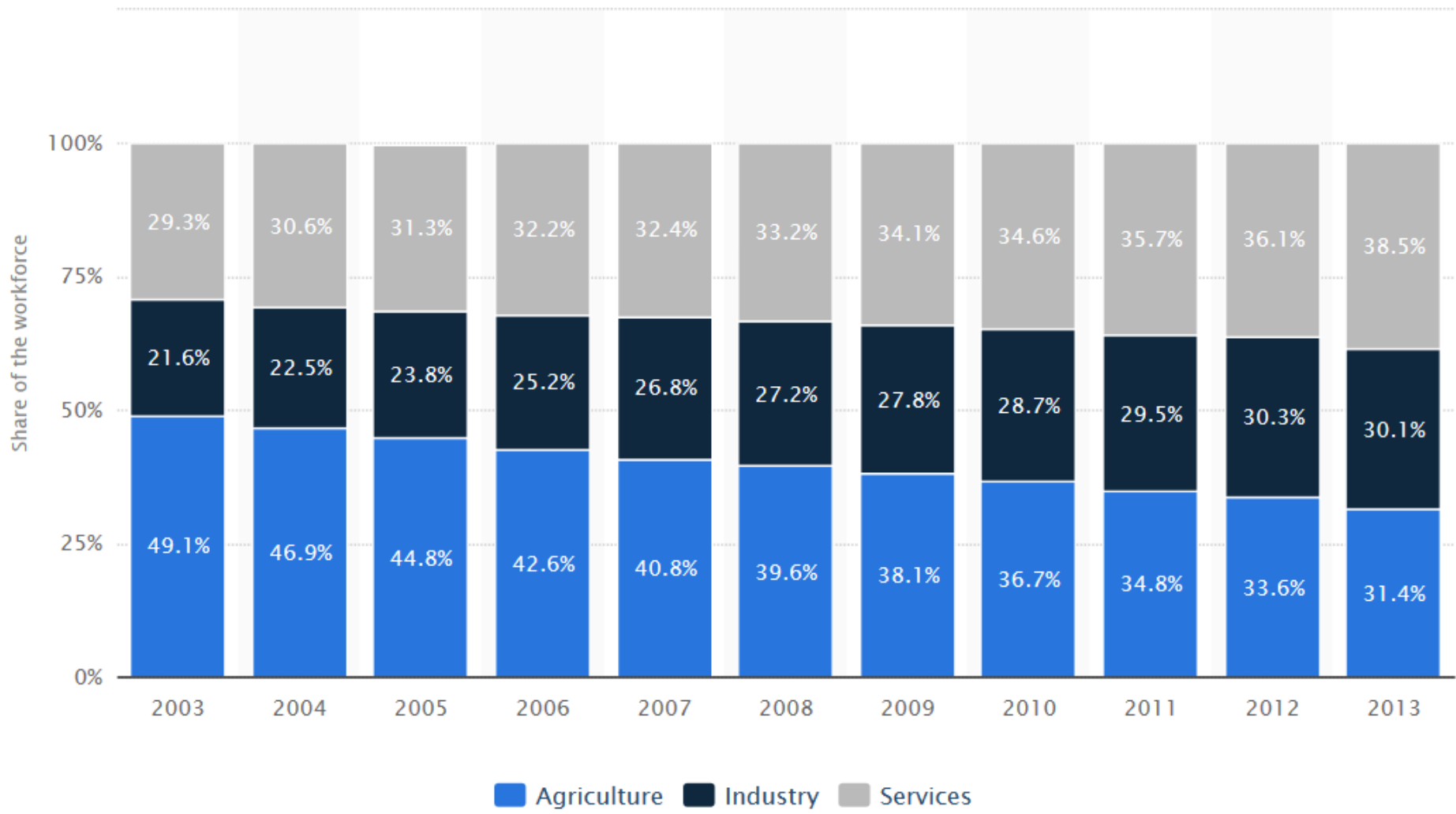

Figure 5: Index of production, annual average growth rates 2005-2011, EU-27 working day adjusted

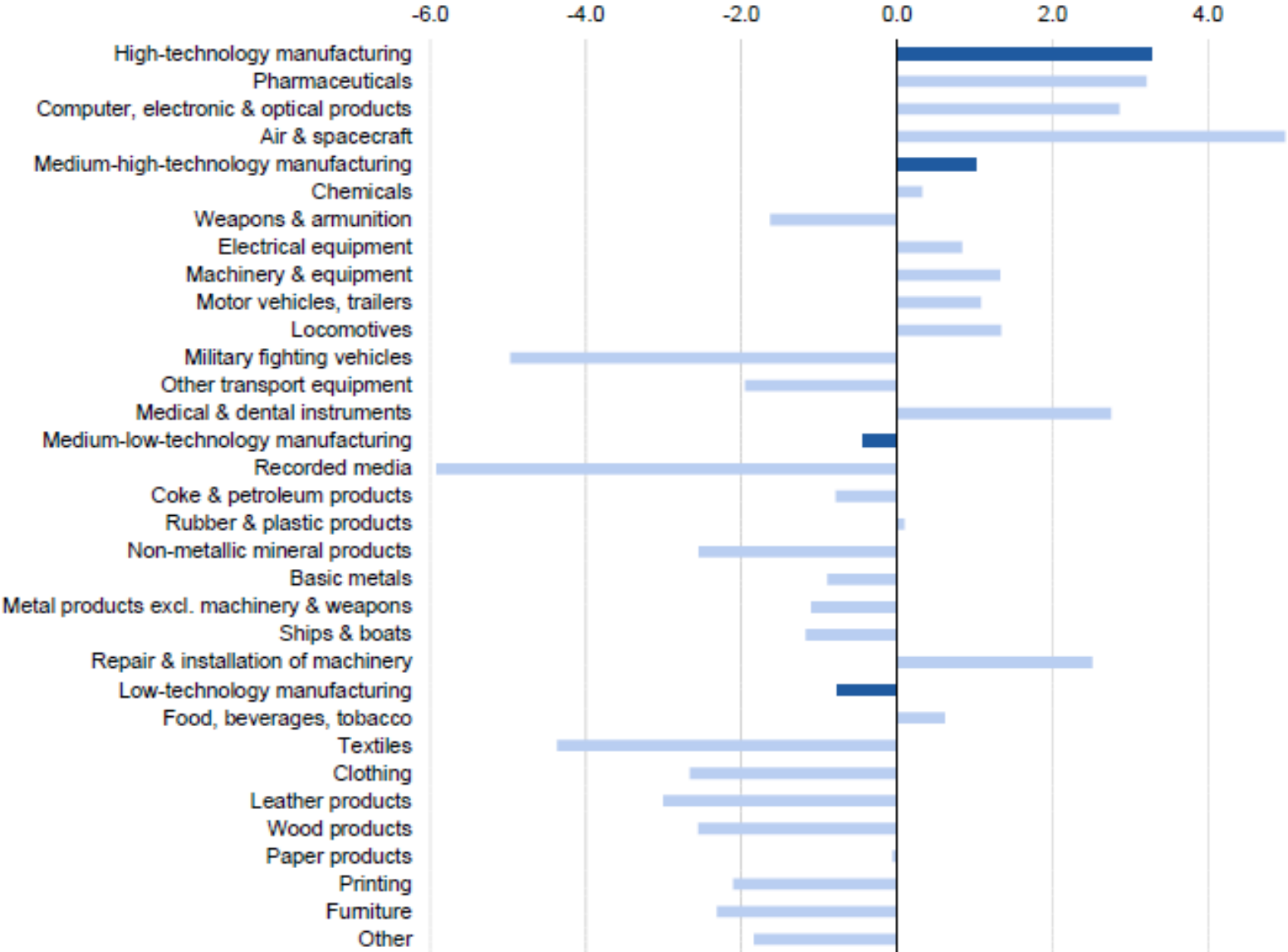
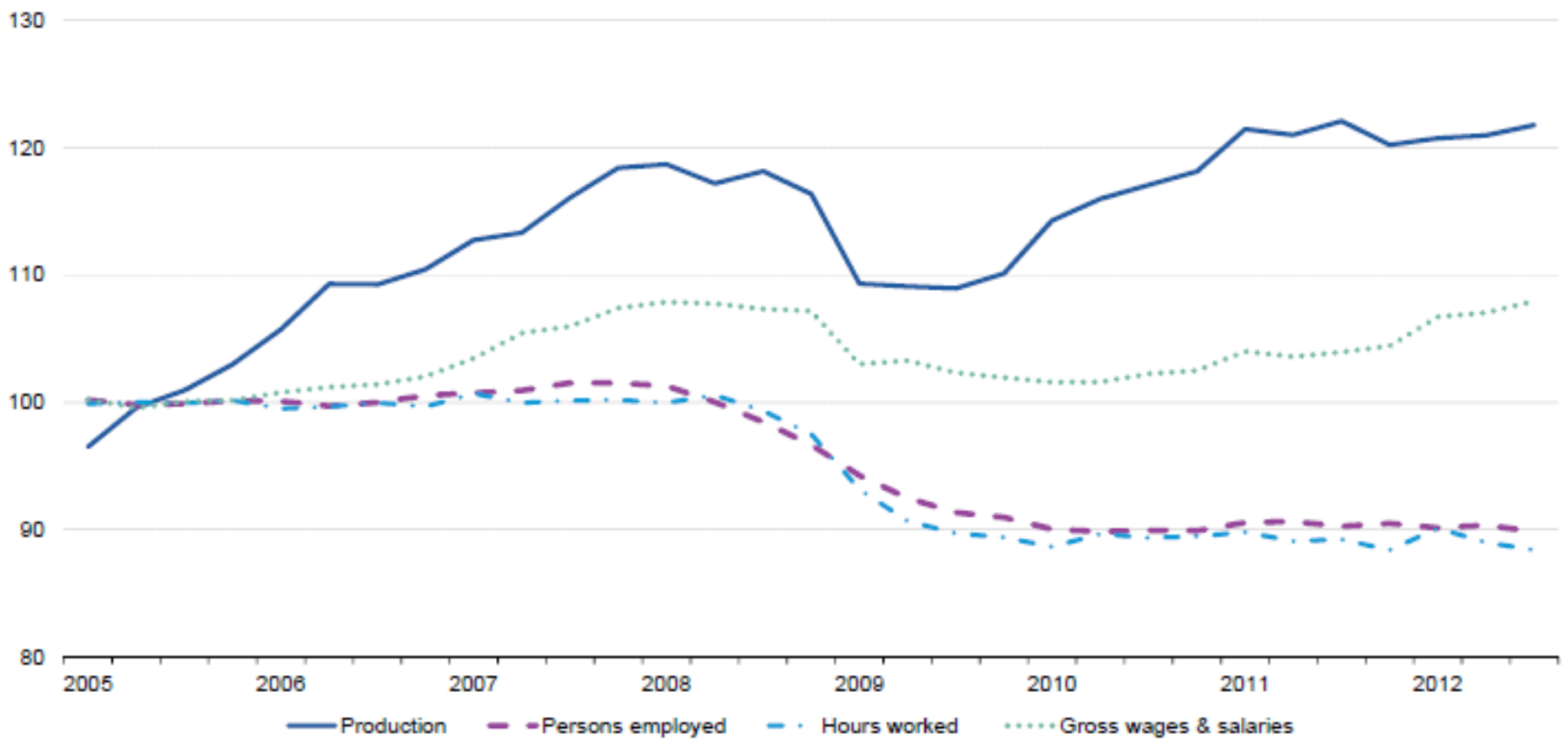

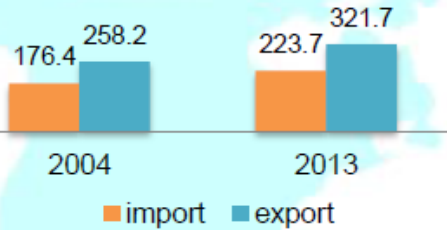
Figure 6: Production and labour input indicators for high-technology manufacturing ⁽¹⁾, EU-27, seasonally adjusted (2005=100)



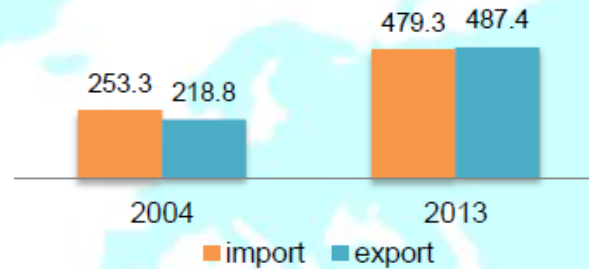

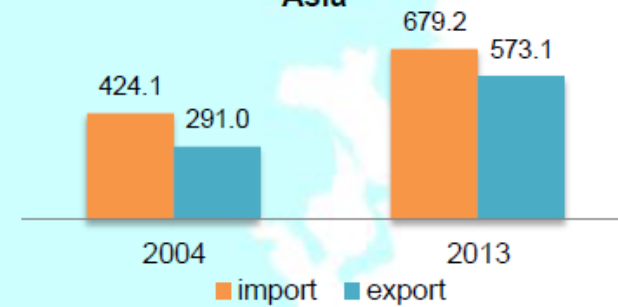

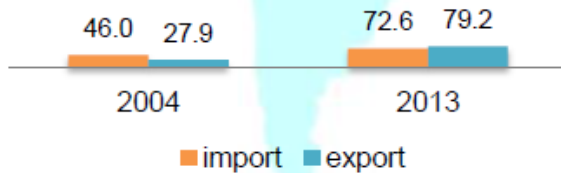

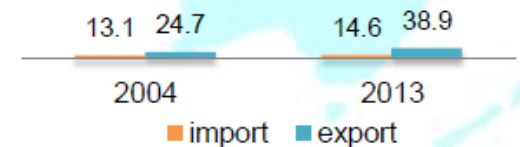

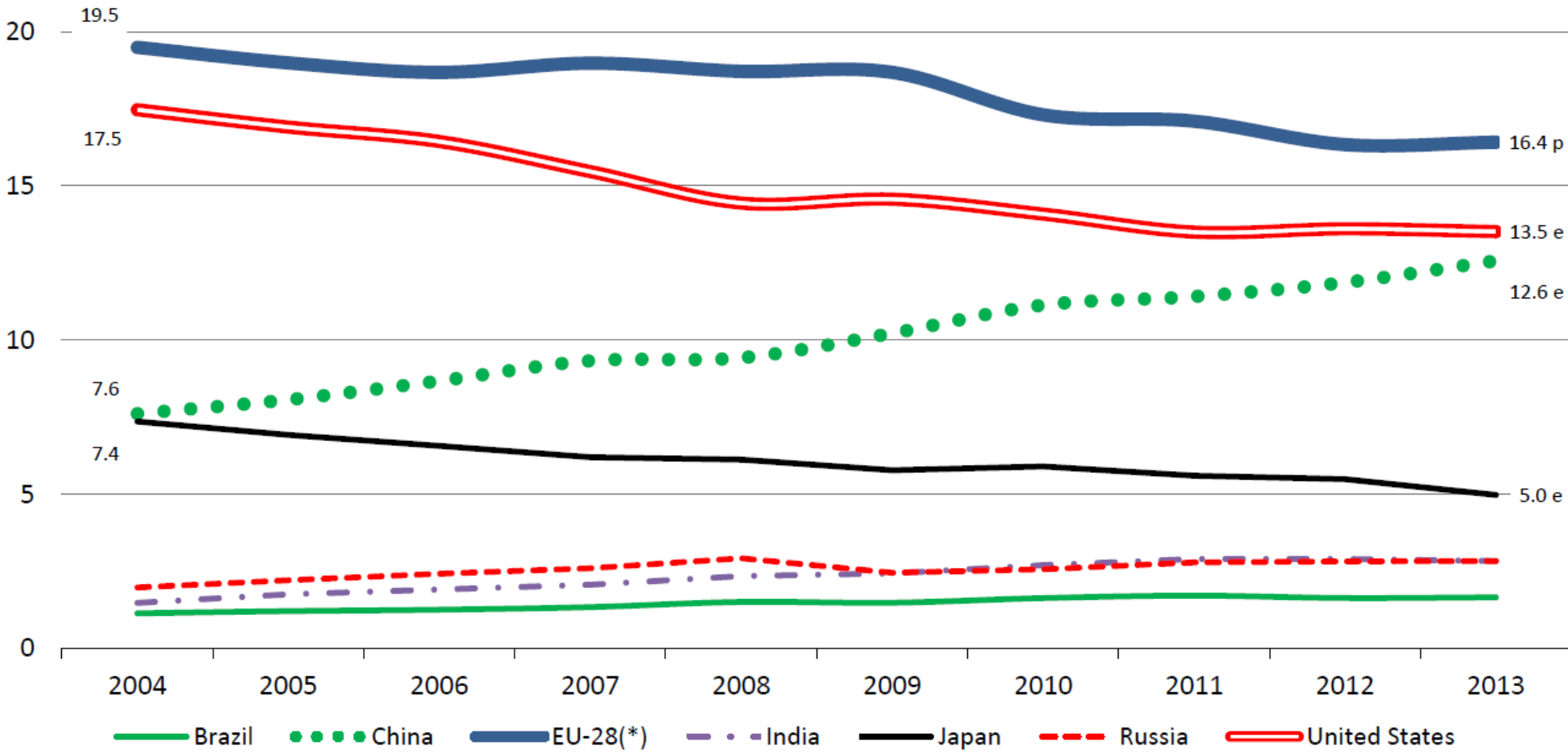

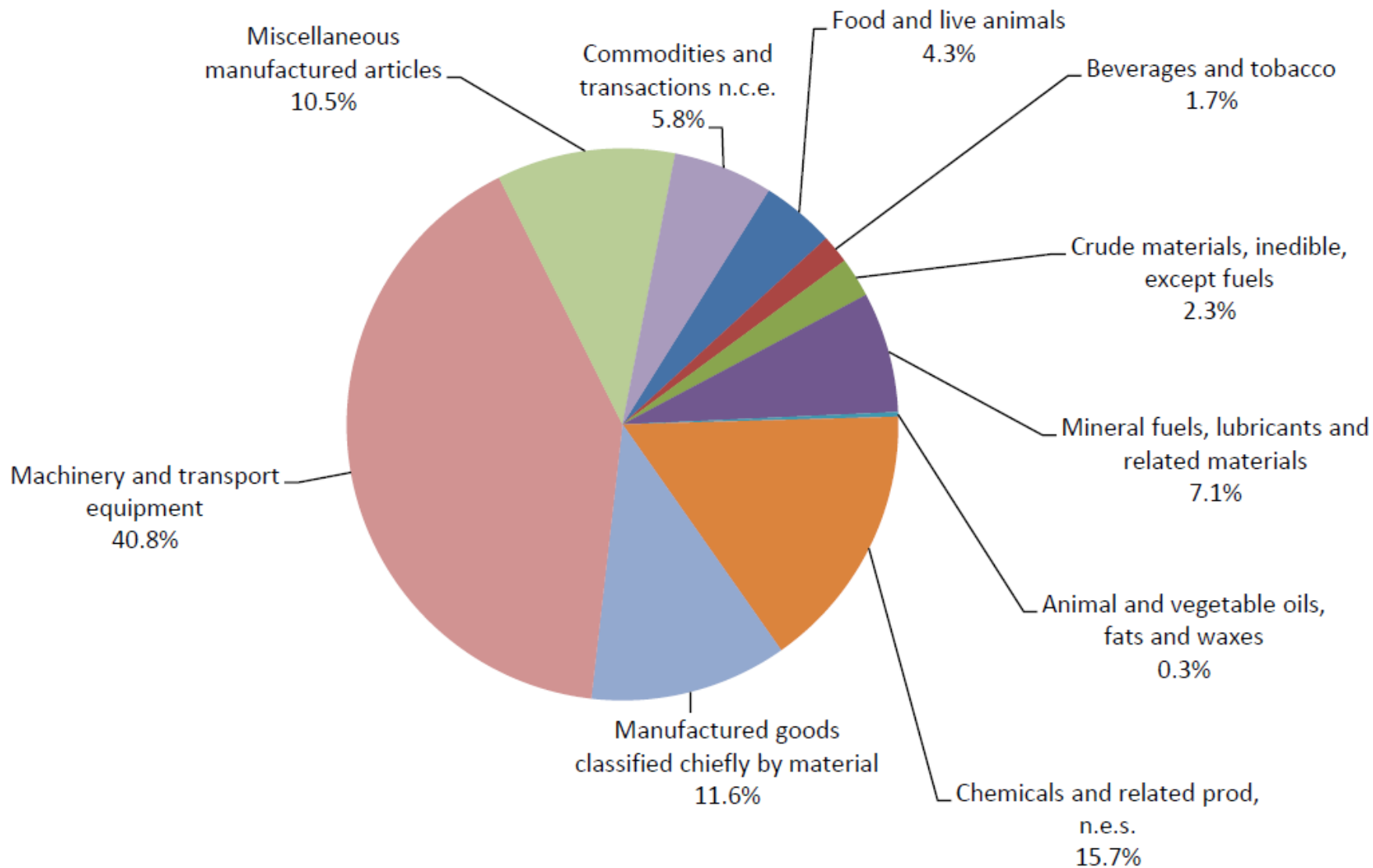

Share in world trade in goods and services in selected countries (%)

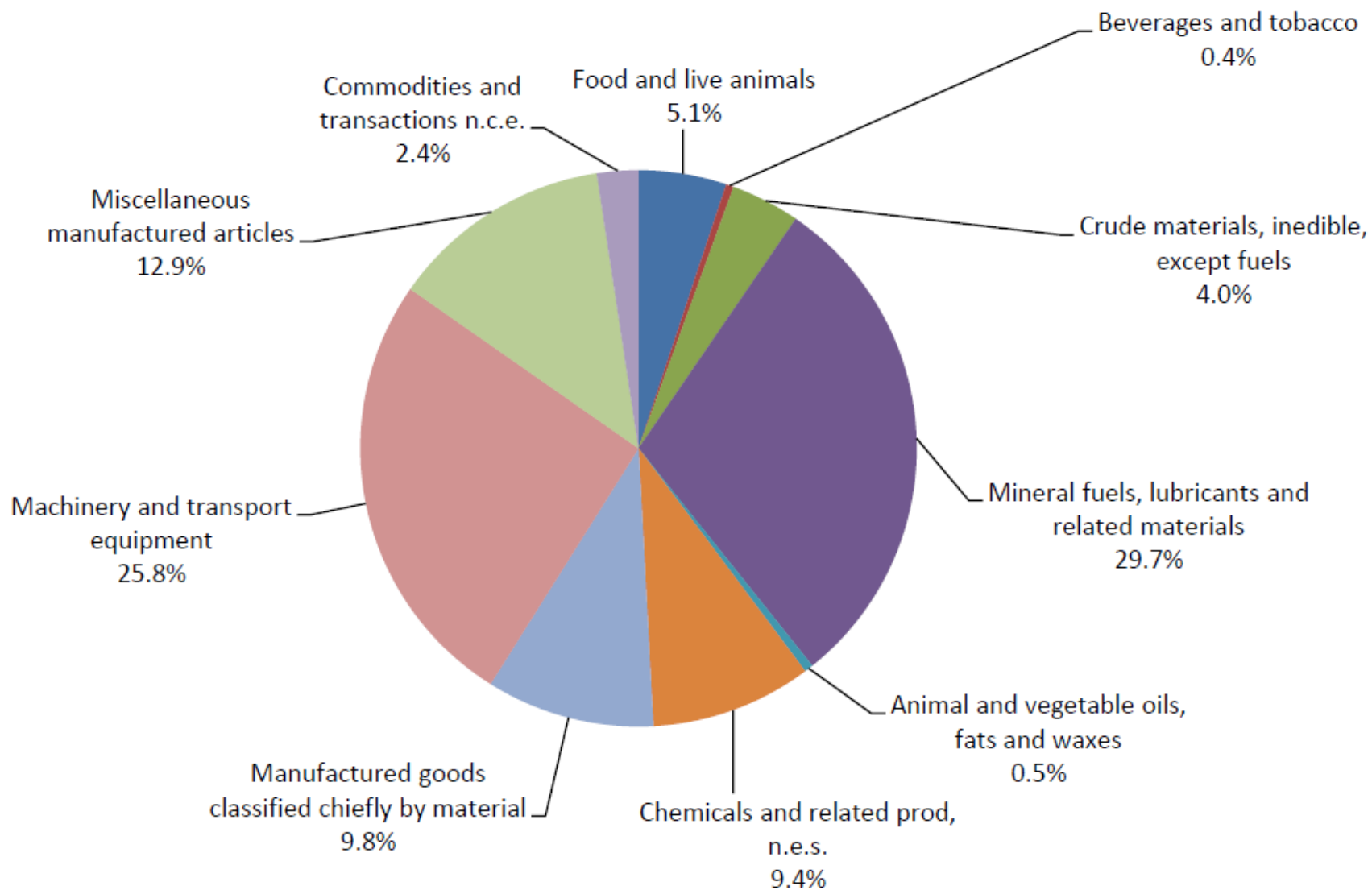

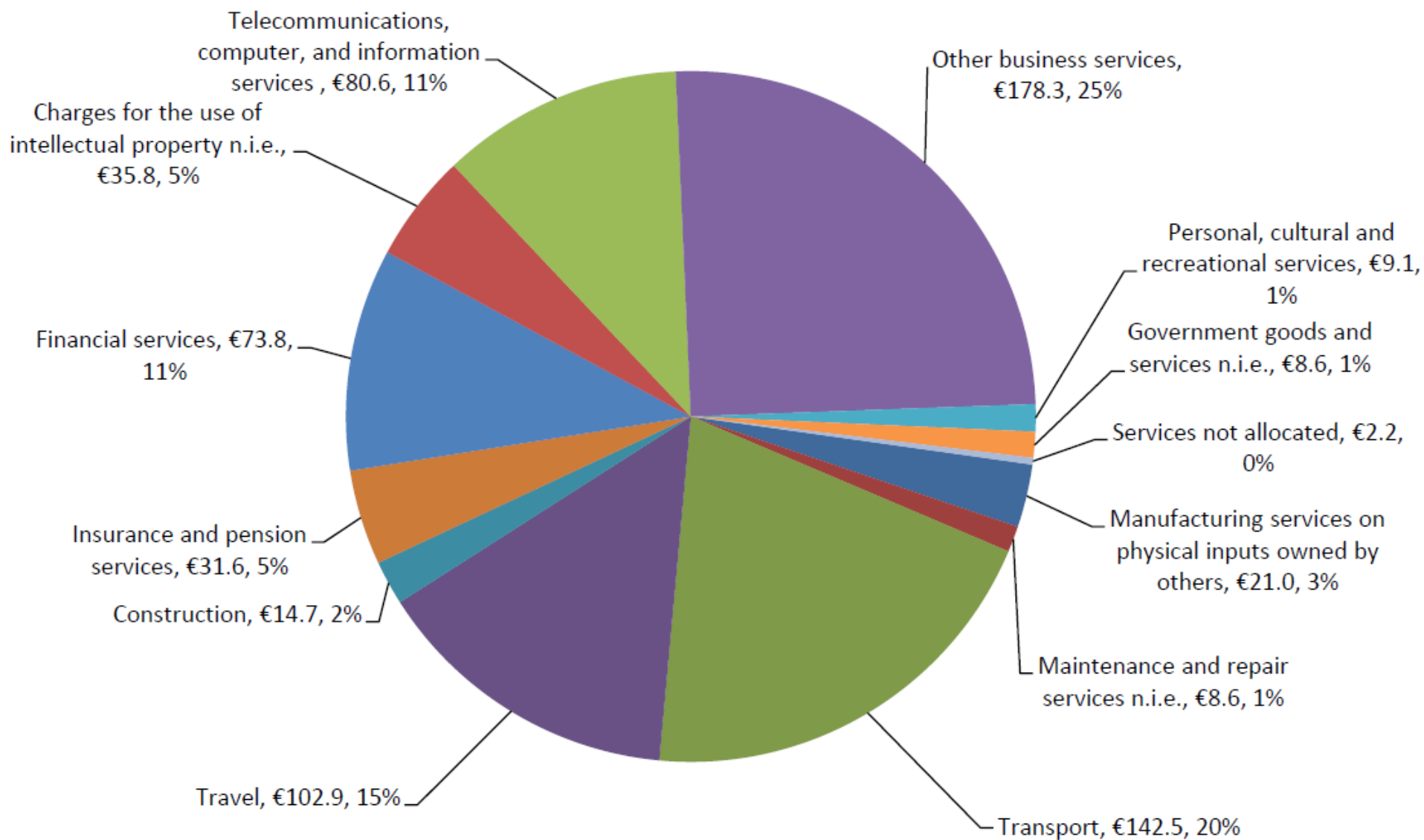

Trade flows by SITC product grouping 2012





