## SPECIFIC JURISDICTION IN TORT "PURPOSEFUL AVAILMENT"

- Designing Product for the Forum Market?
- Providing Promotional Material for Forum?

## SPECIFIC JURISDICTION IN CONTRACT "PURPOSEFUL AVAILMENT"

- Contracting with Resident of Forum?
  - Not Enough Need More
  - E.g., Pre-Contract Negotiations, Visits to Forum,
     Post-Contract Performance and/or Breach
  - Reasonableness
    - Burden on Defendant
    - Forum State Interests
    - Can Pl Get Convenient & Effective Relief Outside Forum?
    - Is Forum the Most Efficient Place to Litigate?

# ALTERNATIVE ANALYSIS OF SPECIFIC JURISCICTION

- DEFINITION OF "MINIMUM CONTACTS"
   DEPENDENT ON TYPE OF CLAIM
  - 1) Commercial Contracts & Products Liability
    - Purposeful Availment
  - 2) Intentional Torts (Defamation, Patent, etc)
    - "Target" or "Effects" Test
  - 3) Internet
    - Sliding Scale of "Interactivity"

#### **SUGGESTED UNIFORM TEST**

For Personal Jurisdiction to Apply:

1) Pl Must Prove that D Intended (Desired) Its Acts to Have Injurious Results in the Forum Jurisdiction (Subjective Test),

or

2) D Should Have Known That Its Acts Were Substantially Certain to Have Injurious Results in the Forum Jurisdiction (Objective Test)

### PERSONAL JURISDICTION OVER FOREIGN CORP BASED ON SUBSIDIARY IN FORUM

FOREIGN PARENT – FORUM SUBSIDIARY Relationship is Not Sufficient to Support Personal Jurisdiction Over Parent.

Need More than Mere Ownership of Property in Forum

- 1. "ALTER EGO" THEORY Extensive Control Over Activities of Subsidiary
- 2. "AGENCY" THEORY The Sub is the Parent's Vehicle for Conducting Business in the Forum
