Dear members of the Advisory Board,  
 as of this moment, we have received a number of troubling reports regarding the status of the healthcare providers located in Nistria, our newest Member State. Because of the potential severity of the incident in question, the Political and Security Committee has resorted to the activation of the Cybersecurity Advisory Board of which you are a member.  
 You are hereby tasked with analysing attached documents (Introductory Information and the Report on Access to Health Services in the EU). We may provide additional documents as soon as we procure them. Next, you are to appear on **May 15th** in the HQ of the Political and Security Committee at the Faculty of Law, Masaryk University to help mitigate the incident with the rest of the Advisory Boards.

We believe that these measures may yet prove to be unnecessary and premature, nevertheless some of our members were quite moved by your previous work and voted to involve you even in this low-key incident.
