Tools of legal regulation Administrative tools: - permits - binding opinions - decision to stop or limit activity - decision to take measures - establishment of protected areas - exemptions.

Tools of legal regulation

- · Economic tools
 - levies for felling trees
 - state support to take measures for enhancing the environment
 - fees to enter national parks
 - tax exemption in the area of national parks
 - financial compensations.

Tools of legal regulation

- Bans and duties of persons.
- Registration (significant landscape components)
- · Administrative agreements.
- · Monitoring and record-keeping.
- Rules for entering the landscape.
- Biological assessment and assessment of impacts of strategic documents and activities in special bird protection areas and in sites of Community interest.
- Management plans for especially protected areas.
- Protective zones.
- Public participation.

Tools of legal regulation Sanctions: - the duty to restore/corrective measures - duty to compensate the damage - natural persons: fine up to 100 000,- Czech crowns (may be doubled) and up to - legal persons and enterpreneurs: fine up to 1 000 000,- Czech crowns (may be doubled) - withdrawal of illegally held specimens.

General requirements

- ban to maltreat,
- · ban to advertise maltreatment,
- · ban to kill unreasonably,
- · ban of certains methods of killing,
- ban to leave the animal with the intention to dispose it of,
- duty to let officers enter the property for inspection purposes,
- duty to take medical care and other measures after anesthesia and others.

Specific requirements

- · slaughter
- transportation
- · pet animals
- · lost and abandoned animals
- · animals kept for farming purposes
- · animals kept for experimental purposes
- protection of wild animals, involving the ban on certain methods of hunting and killing.

Sanctions

- withdrawal of the animal, including the duty to pay expenses related to the withdrawal and veterinary care and other expenses needed to keep the animal
- fines up to 500 000,- Czech crowns
- stop or limit the operation/activity for up to 5 years
- · corrective measures.
