- ◆ TRY TO SUPPRESS UNFAVOURABLE FINDINGS
- ACCEPTING DONATIONS IS CONTROVERSIAL

- ◆ FRAMEWORK CONVENION ALIANCE for TOBACCO CONTROL (WHO) – an UMBRELLA ORGANIZATION OF 200 TOBACCO CONTROL ORGAN. – 2003
- ◆ GLOBALink an INTERNET BASED NETWORK AROUND THE WORLS
- WORLD CONFERENCES "TOBACCO
   OR HEALTH" (3-year periods)



#### WHO FCTC

- ◆ REGULATION: packing, labeling tobacco products, sales to minors, illicit trade, smoking at public places
- ◆ REDUCTION IN CONSUMER DEMAND: price and tax, ban of advertising, education training
- PROTECTION OF ENVIRONMENT AND TOBACCO WORKERS

- ♦ RESEARCH SURVEILLANCE, EXCHANGE OF INFORMATION
- SUPPORT FOR LEGISLATIVE ACTION
