



Vendors of selected medicinal products

Only selected medicinal products

<u>Selected medicinal products:</u>

only by competent vendors of selected medicinal products

• Obtain selected medicinal products only from a manufacturer or from a distributor

- Store them for the purposes of sale under the conditions established in SPC
- Provide information about correct use and storage of the medicinal product (PIL)

doctors, pharmacists or other healthcare professionals of a **nuclear medicine workplace**

only radiopharmaceuticals prepared at this workplace

employees of **public health protection authorities** with professional qualification to engage in the healthcare profession

only immunological products intended for vaccination

doctors, pharmacists or other healthcare professionals of a **blood** centre and a blood bank

only blood derivatives and transfusion products;

doctors, pharmacists or other healthcare professionals of an immunology or microbiology workplace

only human autogenic vaccines prepared at this workplace.

Medicinal products may be, furthermore, dispensed by:

 veterinarians authorised to engage in professional veterinary activities;

Only medicinal products intended for the treatment of animals.

quality of MP - not compromised

 handling of medicinal products before dispensing - conditions established in the marketing authorisation;

• Obligation: **keep records** for the period of 5 years;

Obligation to provide data

• Obligation to **co-operate**:

If a pharmacy - to other pharmacies or inpatient healthcare providers:

specified "in the licence"

• Inform the patient about alternative options

MP may be dispensed also to a **person other than the one for whom** it has been **prescribed**.

• Doubts arise in respect of credibility of the medical prescription,

doubts as to whether the person to whom are products dispensed,
 is able to guarantee proper use of the medicinal product

MAY NOT BE DISPENSED

Suspected abuse

• The conditions / restriction haven't been fulfilled

MAY NOT BE DISPENSED

- -----
- Interactions

(threat to the life or health of the worker)

Conscientious objection

refusal to fulfill a legal obligation due to a conflict with conscience

Refuse

But !!! - another worker will perform needed service / another health care facility

Never - If there is a possibility of:

- a threat to the patient's life
- serious threat to patient's health due the refuse

Dispensing OTC - ethics

Medicinal products - Rx Only

Medicinal products shall be available only on medical prescription:

 present a jeopardy either directly or indirectly even when used correctly if taken without medical supervision;

• frequently used incorrectly, and as a result can present a direct or indirect jeopardy to human health;

Medicinal products - Rx Only

contain substances serious adverse reactions

• intended for parenteral administration

 contains a substance classified as narcotic or psychotropic or a precursor in amounts not allowing for being dispensed without medical prescription

Medicinal products - Rx Only

• lead to addiction or be misused for illegal purposes

due to its novelty



Dispensing of Rx only

Informations

- necessary for the safe use of the product
- necessary for handling with the product
- inform the patient upon the actual amount of total reimbursement covered by the public health insurance for the dispensed packages for each item in the medical prescription; CZE
-patient counselling

Reimbursement vs Co-payment CZE

Annual limit based on "Eligible" co-payment

Reimbursement from the public health insurance

 List of medicinal products and foods for special medical purposes with reimbursement from the public health insurance

Updates – every month

Information

OTC with restricted dispensing

In this category if:

- causing jeopardy to human health which might be prevented by setting:
 - certain restrictions on such dispensing
 - prior expert consultation with a pharmacist

OTC with restricted dispensing

Such medicinal product may **only** be dispensed:

to the person for whom it is intended,

The provider authorised for the dispensing - obliged to maintain records of its dispensing.

OTC with restricted dispensing

• Details and further restrictions may be established e.g.:

- age limit
- dose for individual administration

period of time.

OTC with restricted dispensing CZE

Pseudoephedrine

• the total amount of pseudoephedrine for an individual dispensing shall not exceed 900 mg pseudoephedrine

And shell not exceed 900 mg in 7 days concurrently

emergency contraception

• From 28.11.2011 – till Spring 2015: OTC with resctriction

• NOW - OTC!!!

In this category:

- due to its **pharmaceutical characteristics or novelty** or in the **interest of public health protection**, reserved for disease treatment which may only be conducted in **inpatient** healthcare facilities;
- is used to treat diseases which must be diagnosed in an **inpatien**t healthcare facility or in healthcare facilities with adequate diagnostic equipment even if the administration and follow-up need not be carried out in such facilities;

• is intended for **out-patients** care but its use may produce **very serious adverse reactions** or may represent significant risk of abuse requiring special supervision is ensured during treatment.

Only by specialists

E-prescription CZE

• **Restrictions** on the **amount** of a medicinal product dispensed to a single patient over a specified period of time can be set.

• "Medical Cannabis":

Abortion pill / or induction of the birth under special condition

Central repository for medicinal products with restriction

• SIDC

Dispensing for health care facilities

Not only original package

Medical Orders

Dispensing - orders

Not only for health care facilities

- OTC whose dispensing, according to the marketing authorisation, is not restricted
- Food supplements,...

• Rx medicinal products – only with prescription

Mail-order dispensing

General principles:

Announce to SIDC

Publish information about:

• products on offer,

prices and costs associated with the mail-order dispensing

• Link to SIDC

Obligations:

Ensure the origin and quality (packaging and transport)

OTC whose dispensing is not restricted


collect information on suspected AR and QD of MP

Paper form of medical prescription CZE:

- CD
- Exceptions from e-prescription:
- "Emergency", failure of Central repository,...
- Prescription for MP, if the patient would like to také the MP in other EU country
- Veterinary prescription

E-prescription only:

- Rx drugs with restriction

Insurance in CZE

- Compulsory health care insurance system
- Consists of not-for-profit health insurance companies

• Health insurance company - freedom of choice,

Insurers

- 111 Všeobecná zdravotní pojišťovna ČR (VZP ČR)
- 60 % of the population
- Other health insurance companies, which are referred to as "employee insurance companies":
- 201 Vojenská zdravotní pojišťovna České republiky (VoZP ČR)
- 205 Česká průmyslová zdravotní pojišťovna (ČPZP)
- 207 Oborová zdravotní pojišťovna zaměstnanců bank, pojišťoven a stavebnictví (OZP)

Patient information

- Name
- ID
- Address
- Telephone number only with agreement of the patient
- Year of birth only if it isn't in the ID
- Weight of preschool children if it is unusual

Medical Prescription

Medical prescription:

- 2 different medicinal products,
- limit 3 months therapy;
- More than 3 months prescription for repeating dispensing
- 1 medicinal product narcotic drugs or psychotropic given lists

Medical order:

- No limit for medicinal products
- 5 different medicinal products narcotic drugs...

Medical Prescription

• Brand name, dosage form, strenght, package

• INN of the substance, dosage form, strenght, package

Name of the substance written in the Pharmacopoeia, synonym or abbrevitation in the Pharmacopoeia - prepared medicinal products

• Which benefits are associated with prescription via INN name of the active substance (not by brand name)

Diagnosis - ICD

 International Classification of Diseases (ICD) by the United Nations and World Health Organization

 "standard diagnostic tool for epidemiology, health management and clinical purposes"

Noninfective enteritis and colitis (K50-K52)

Incl.: noninfective inflammatory bowel disease

Excl.: irritable bowel syndrome (K58.-)

megacolon (K59.3)

K50 Crohn disease [regional enteritis]

Incl.: granulomatous enteritis

Excl.: ulcerative colitis (K51.-)

K50.0 Crohn disease of small intestine

Crohn disease [regional enteritis] of:

- duodenum
- ileum
- jejunum

Ileitis:

- regional
- terminal

Excl.: with Crohn disease of large intestine (K50.8)

K50.1 Crohn disease of large intestine

Colitis:

- · granulomatous
- regional

Crohn disease [regional enteritis] of:

- colon
- · large bowel
- rectum

Excl.: with Crohn disease of small intestine (K50.8)

Prescribers

- Physicians human, veterinary providing preventive health care
- Physicians not providing preventive health care (i.e. university employees, pensioners etc.) if:
 - Mini-license with the insurance company where they are insured
 - Possibility of prescribing Medicinal products for themselves and family members if they are insured with the same insurance company
 - Member of the Czech Medical Chamber or the Czech Dental Chamber (liable for their professional competence)
 - In the insurance must be announced the ID number of family members, to which will apply
 prescribing the right
 - Note in the prescription "for familiy mamber" or "Ad usum proprium"

"Exspiration" of Rx in CZE:

• 14 days

• 5 days

• 1 day after prescribing
