## Pharmacy retail price - calculations II

In the Czech Republic there is statutory pricing for all reimbursable pharmaceuticals.

Prices of non-reimbursable pharmaceuticals are not regulated.

The maximum pharmacy retail price based on maximal wholesale and pharmacy mark-ups and VAT.

VAT in Czech pharmacies standard VAT rate 21% 1. Reduced VAT rate 15 % 2. Reduced VAT rate 10 %

#### Products without price regulation

Pharmacy bought Lip balm BIODERMA Atoderm : purchase price: I58,00 CZK without VAT.

(standard VAT)

Decide for the mark-up: 25 %. Pharmacy retail price with VAT:?

PRP without VAT =  $158,00 \times 1,25$ PRP without VAT = 197,50 CZK

PRP with VAT =  $197,50 \times 1,21$  CZK PRP with VAT = 238,98 CZK

# Medicinal devices with price regulation

Maximal mark-up 25 % of the Ex-factory price

It is common wholesale and pharmacy mark-up There are no official agreements on how the mark-ups are split.

VAT: reduced or standard

# Medicinal devices with price regulation

Ex-factory price: 30 000 CZK.
Group: I. reduced VAT

Maximal pharmacy reatail price (with VAT):?

PRP without VAT = (Ex-factory price + markup)

PRP without VAT =  $30\ 000\ \times\ 1,25$ 

PRP without VAT = 37 500 CZK

PRP with VAT =  $37500 \times 1,15$ PRP with VAT = 43125 CZK

Zones of Ex-factory price

How to calculate the price of medicinal product? Choose the zone according to Ex-factory price

Add the mark-up according to the zone

Add VAT – human medicnal product with marketing authorisation – 10%

Medicinal product with price regulation ALMEDO 10 mg por tbl flm 100 x 10 mg Ex-factory price = 255,72 CZK

Pharamacy retail price (PRP) with VAT:?

Zone 2 mark-up additional part

PRP = (255,72 x 1,33 + 6) x 1,10

( Round down!)
