#### **SPECIFIC TYPES OF INTERVIEWS**

elite interviews & online interviews

- Difficulties during approaching participants (timing, busy schedule of politicians, journalists)
- II. Demands for preparation (particular review)
- III. A risk that we won't have a chance to do an additional interview with the same person
- IV. Different dynamics in a researcherparticipant relationship (participants hold equal or greater power)

# What might be advantages of online interviews and what might be different?

#### SPECIFIC CHARACTERISTICS OF ONLINE INTERVIEWS

- Being well prepared with technique (choice of platform for a call, recording, Wi-Fi connection)
- Sound and pictures are core
- Ice breaker not all tactics from f2f interviews will work
- Difficulties with flow
- The online choice depends on the topic and preferences of the participants



### Additional methods of data collection

applicable for observation and interviewing

#### Monday

# The role of field notes

#### FIELD NOTES (Kotišová, 2017)

A reporter Ella and two editors (Marie and Václav) discuss where the fence that the report is supposed to cover is: 'It is on Macedonian-Greek border!' 'No, on Serbian-Hungarian border!' 'No, on Macedonian-Greek border', Ella says. She had written the headline and Václav changed it. Marie supports Ella and says a screen should be made, depicting graphically when and where the anti-immigration fences have been built. She is flourishing her arms in the air: 'And they built it first here, then here, then here'.

Marie says that 'we do not look into anything except of the Brussels, so we are going to work hard today'. [...] Marie sits back against the armchair and sighs: 'Oh, what a day again. Nothing happens ...' [...] After a while, Marie says in a bored way: 'I should've brought the knitting with me'.

#### Notes about the process of the interview

Reflection of emotions from the interview by the interviewer

Unpleasant questions, pauses, hesitance


Any disturbing elements
